MINUTES OF THE MEETING OF SANITARY AND IMPROVEMENT DISTRICT NO. 5, CASS COUNTY, NEBRASKA

Meeting convened at 6:00 p.m. on April 23, 2024, at First State Bank Nebraska, second floor community room, 446 Main Street, Plattsmouth Nebraska. Attached hereto are: the agenda for the meeting; the Affidavit of Printer verifying that notice of the meeting, stating the availability of the Agenda, was published in the *Omaha World-Herald*, a newspaper of general circulation in Cass County, Nebraska; advance notice of the meeting as provided to the County Clerk of Cass County and all Trustees; and the Trustees' acknowledgment of receipt of said notice and agenda. All proceedings were taken while convened with attendance open to the public.

The Chair was called away to a medical emergency.

ITEM 1

The Clerk called the Meeting to order at 6:00 p.m.

ITEM 2

The Chair announced the locations of the Open Meetings Act and documents related to the agenda.

ITEM 3

Roll Call: Present: James Grotrian, Robert Karr, Jennifer Sommer and David L. Martin. Absent: Kurt Meisinger.

ITEM 4a

Messrs. John Reimer and Brandon Vandermey of Viking Industrial Painting provided a presentation regarding a proposed contract for water tower maintenance which is renewable annually. There was a significant question and answer session about the tower and about how the program would address issues and prioritize work. No action was necessary. Trustee Martin advised that another company requested a chance to make a presentation and then proposal.

ITEM 4b

Trustee Martin advised that there was a delay in work on the wastewater treatment plant while waiting on the delivery of parts. The tablet for reading water meters worked well with issues at only about four or five residences. The well house remodeling project was proceeding quickly. There may be two residences sharing one connection which would violate the Rules and Regulations.

ITEM 4c

PeolpeService's report is attached. The mowing contract should include the lift stations and the access to the wastewater treatment plant added. If it is necessary to add the locations, the Board recognizes that there will be an adjustment in price.

ITEM 4d

Trustee Martin and Mr. Johnson advised that there was no new information regarding water system improvements including possible connection to a water main the City of Plattsmouth may construct to connect to Metropolitan Utilities District.

ITEM 4e

There was discussion about suspending the lawn and landscaping watering policy for 2024. Action on the question will be considered in Item 4f.

ITEM 4f

Motion by Grotrian, seconded by Karr to adopt the revised Water System and Sanitary Sewer System Rules and Regulations dated this date. On roll call those voting aye: Grotrian, Martin, Sommer and Karr. Voting nay: none. Absent: Meisinger. Abstaining: none. The Clerk declared the resolution adopted.

ISSUE 5a

Trustee Karr reported that he was meeting Dan Dolezal to evaluate street repairs for patching or overlay. Replacing the sod that died at the erosion repair site was necessary. Trustee Karr was waiting on a proposal from JEO for repairs at the water tower.

ITEM 5b

Motion by Karr, seconded by Martin to terminate the snow plow contract with Lakeside Landscaping, Inc. and authorizing the solicitation of proposals. On roll call those voting aye: Grotrian, Martin, Sommer and Karr. Voting nay: none. Absent: Meisinger. Abstaining: none. The Clerk declared the resolution adopted.

ITEM 6a

Trustee Grotrian reiterated that the mowing contract would require an amendment to include the lift stations and road to the wastewater treatment plant if not already included. A downed tree on the west side of the main entrance was removed.

ITEM 6b

Trustee Grotrian asked Mr. Johnson to review the proposals for the mowing contract. Aspen Landscaping was the low bidder at \$620.00 per mowing. The other two bids came in at \$700.00 and \$1,250.00. Following the review, Trustee Grotrian advised that, as decided by the Board at the last meeting, the Committee awarded the mowing contract to Aspen Landscaping.

ITEM 6c

Following discussion concerning entrance improvements and a park on a lot near the entrance, Trustee Sommer advised that she would begin the hunt for a grant writer. No formal action was necessary.

ITEM 7

Motion by Grotrian, seconded by Martin to approve and authorize the Chair to execute, a contract with Gretna Sanitation for District-wide trash collection service for a five-year term. On roll call those voting aye: Grotrian, Martin, Sommer and Karr. Voting nay: none. Absent: Meisinger. Abstaining: none. Trustee Martin declared the resolution adopted.

Trustee Martin raised the issue of which committee would be responsible for addressing issues related to trash collection and suggested renaming the water and wastewater committee to the "utilities committee" and have it be responsible for handling trash collection issues. The Trustees did not oppose these actions.

ITEM 8

Following discussion concerning a mass mailing for transition to Gretna Sanitation for District-wide trash collection service, no action was necessary.
