

Getting to know Buc Bay residents

### Catering to Buc Bay community

To say Jennifer Sommer enjoys cooking might be the understatement of all time. Yes, she was introduced to her grandmother's kitchen when she was 5 years old. But even so, with so much on her plate you wonder what she was thinking by taking the initiative (with husband Sean's blessing and help) to go full-bore into the catering business.

That's just what the couple did when they launched their venture, Sommer Butts, Brew & BBO LLC, which opened in downtown Plattsmouth last March. While the process was difficult, Jenn and Sean said in a recent interview, it was worth clearing each hurdle.

Before getting to that, you should know more about Jenn and

Sean. Jenn, who grew up in South Omaha, met Sean in 2016. They were married two years later, of a busy life for the couple.

"Talk about a whirlwind," Jenn said. "In

April I graduated with my bachelor's degree (from the University of Phoenix). In May we bought the house (on Buccaneer Boulevard) and in July we got married — all within 90 days.

"I don't recommend something like that to happen so soon. One of those in a year is stressful enough, let alone three in 90 days."

They were living in a home near the Bellevue Medical Center before moving here. Sean, who has served in law enforcement approaching 30 years, wanted to find a home in Cass County since he's a sergeant with the Cass County Sherriff's Office (where he started in 2013). Sean spotted the house while on duty one night.

"I had no idea that this housing addition even existed," Jenn said. "We came out and saw it, and I told him, 'Don't fall in love with this house, because we're not going to get it.' He said, 'It's too late. I already did.' So we moved in."

The couple, who have six children together from previous marriages, were living here less than a year before the 2019 flood

hit. That's when they found out that Buc Bay is a caring community. They became a distribution site of sorts for donations for people whose homes were damaged by the flood.

Becoming involved in her neighborhood is a natural for Jenn. She serves in a director's role with the nonprofit called Cass County Behind the Badge. It supports first responders from all of Cass County.

"Every holiday," Jenn said, "I'd feed them well. It kind of morphed from there. I had fire chiefs tell me I had to do this for other people."

The next thing Jenn knew, she was cooking for others. Most often, she was able to take care of catering jobs from home. There were notable exceptions, like the time she relied on the Murray Fire Department's larger kitchen for a bigger gig.

Said Sean: "It finally got to the point where we discussed it, and

she realized that at this point we needed a commercial kitchen to keep up with this (growing) business. It was such a pain to haul everything to a certain location for prep work, get it ready, then take it back home and then deliver it."

Late last year, the couple got serious about seeking a home to expand and accommodate her new venture.

"About eight months ago we started looking," Jenn said. "We looked in Syracuse and Nebraska City. Some of the kitchens were massive — one was like 3,000 square feet."

Added Sean: "The one in Nebraska City looked like it was a steak house, and they added sections in pieces. A lot of them needed so much work. We didn't have that kind of funding. We weren't going into this as a restaurant business. We were going into it as a catering business."

Then Jenn learned that the downtown Plattsmouth ice cream shop space was vacant on the ground floor of the Fitzgerald Building. A real estate agent gave Jenn some bad news.

Said Jenn: "She said, 'No, absolutely not. They don't want another food vendor in here.' About 45 days went by, and I called her back, and I told her a lot of what we were going to do was not going to be done in that building."

Jenn and Sean then met with the owners of the 100-year-old building and explained their business plan. They immediately got the OK to proceed.

Said Sean: "A lot of times we were sitting there thinking we weren't going to find the right space. This was the right space."

Turning that "right space" into the home for the catering company was a challenge to say the least. The couple took possession Jan. 11 with the hope of a grand opening on March 10 - 60 days later - and then found there were many hurdles to clear before that could happen.

Permits had to be pulled and inspections needed to be passed before the business could be launched. The couple agreed it was a bit stressful due to a couple of unforeseen delays.

"We really hit the ground running," Jenn said. "I think God had a plan. I heard people say, 'Is Plattsmouth ready for a caterer? What does that even mean?' There's a lot of misconception of what a caterer really does."

Starting out, Jenn was prepared to cater for as few as one person or hundreds.

"I had a lady who was getting ready to have knee surgery," she said. "When she got home she was out of commission. So she hired me to cook seven to 10 days of meals just for her. I'd put them in her freezer."

Then there's an August wedding scheduled that she will handle

for 350 guests.

During the interview at their store the day before Memorial Day, customers stopped in to collect their food. Any order that involves smoked meat must be placed at least 48 hours in advance. All the meats are smoked at their home and then prepped at the space for delivery or pickup.

The store is large enough to accommodate a small group of diners — by reservation. Large ovens are used to cook side dishes and keep food warm. Most often, their company delivers to area homes. Graduation parties last month kept them extremely busy.

Before the catering-business idea hatched, Jenn ventured into the world of politics. Newer Buc Bay residents probably don't know she served out the term of Janet McCartney, who stepped down in 2021 after 11 years as a Cass County commissioner. Jenn was defeated by Taylor Boyle in the following election when that term was up a year later.

She doesn't regret taking on the commissioner's role, even if it lasted just a year.

"I did commissioner work every, single day," she said. "It didn't matter what time of the day. You're on 24/7."

Even though she's not a commissioner, she still interacts with the Board as its Information Technology consultant.

Not discouraged by that defeat, Jenn was urged by friends to throw in her name as a replacement when a vacancy came up last year for the SID Board. She feels it was a natural step to

take as a public servant.

She's glad to answer the occasional phone call or email from Buc Bay residents seeking information or assistance with a matter of concern.

"I want to do what I can for the community and represent them the best I can." she said.

Jenn likes to "escape" to her home away from home — their downtown catering headquarters.

"This space is my super power," she said. "I don't care if I have a headache. I don't care if I don't feel good. When I walk into this building it all goes away."

Before opening, Jenn took charge of decorating the seating area of the store. The walls contain family photos, including one of her grandparents.

"My grandma taught me how to make Italian gravy," Jenn said. "My dad was the head chef at Johnny's Café before I was even born. Yes, I've always loved to cook."

She takes enormous pride in the products she sends out the door or delivers to homes.

"That's my name, my reputation and my food," she said. "I taste everything. Everything has to be tasted before it goes out the door."

Long before she got seriously into catering, Jenn took part in barbeque cook-off competition. She phoned her dad, who was then retired, and said, "We're going to compete in a barbeque contest."

This was a big-time Omaha event, sanctioned by the Kansas City Barbeque Society. Jenn and her dad were competing against 71 other teams from all over the country in the mid-1990s.

Said Jenn: "We called ourselves 'The Backyard Barbequers.' That first year we finished 70th (out of 72)."

The following year, they outcooked 12 teams. The fifth year of

competition, she and her dad placed 10th in the brisket division out of 72 teams.

After taking time away from competition, she introduced Sean to it. Last May, the couple entered the Smoke Your Butt Off contest in Weeping Water.

From there, Jenn went to the other side of BBQ competitions by becoming a KCBS-certified contest judge.

Their business is growing through word of mouth, but it's apparent that the word is spreading as they're keeping quite busy. That doesn't mean they don't make time for enjoying the company of their neighbors.

"Everybody really comes together here," Jenn said. "I would say for me it's the people, the community. I've never had the best neighbors like I have now."

Said Sean: "We literally know everybody on either side of us on either side of the street. We love Plattsmouth, we love the community."

### Switch to Gretna to begin on July 3

At its April meeting, the SID Board officially approved the proposal to switch all residents to Gretna Sanitation. It takes effect July 3. The contract that was signed is in place for five years.

Under the new plan, residents will be charged the monthly fee that includes the months you might be away during the winter. Trash fees will appear on your monthly water bill as a separate item.

Trash pickup will take place each Wednesday, except for major holidays (Christmas, New Year's Day, etc.) that fall on weekdays. All Buc Bay residents should have been notified by mail.

Residents who don't currently use Gretna should be getting new receptacles.

### Rainy May helped reduce water use

With that incredibly wet month of May behind us, residents are still being urged to follow the directives for outside water use. Here are the guidelines:

- Even numbered addresses may water lawns and landscaping only on Tuesday, Thursday, and Saturday.
- Odd numbered addresses may water lawns and landscaping only on Wednesday, Friday, and Sunday.
- Watering lawns or landscaping is not allowed on Monday.
- If the property owner waters the lawn and landscaping only with a rain water reclamation system or the owner's private sand point well, and does not use the District's water system, the owner is exempt from these rules and regulations.

### Street sign on Davy Jones is missing

A resident reported last month that the street sign for Davy Jones Circle and Davy Jones Drive fell from its pole. When SID Board member Dave Martin looked for it, the sign was gone.

Residents no doubt would appreciate the return of the sign. That way, visitors will be able to find the right street.

We couldn't qualify for a loan, so my parents co-signed the loan that allowed us to live our remaining two years of military life in a trailer park.



### Rainy May was one for the books

What a difference a year made for the month of May. A year ago, we endured the driest May on record. Twelve months later came the wettest month on record. While the constant rains allowed homeowners to turn off the sprinklers, it was a challenging time for our golf course. Bay Hills superintendent Steve Bogner said he hasn't seen anything like it since his arrival in 1984.

"We have had years where it would rain for a week," Steve said, "and we never thought we would be able to mow, but we would get through it somehow. We will take the rain when we can get it. We just wish it would not come with high winds, hail and tornados."

Amazingly, the course held up well with some of the heavy storms, Steve said, but the rain forced him and his crew to mow more often than usual.

"We mow every day even in the rain as long as it isn't lightning," he said. "It is hard on the equipment when the grass is thick and wet. The belts and blades wear out faster, and the mowers use more fuel. We also have to mow more often so the grass doesn't clump up."

Another problem came when heavy rain washed out the sand in the traps that was added this year. The conditions didn't impact play as much as you might think.

"We have only closed the course down for an afternoon to allow the course some time to drain," Steve said. "The course does drain well for the most part. We have posted cart paths only

### Buc Bay junior right on target in trap

Kasten Hellbusch had quite the ending to his junior year of high school. At the May 2-4 Nebraska state trap meet, he placed 54th overall. Approximately 1,600 competed at the Doniphan meet, and Kasten placed second for high overall on his Bellevue trap team.

"For him to finish 54th (overall) is a huge deal," his mother, Deanna, said last month on Facebook. 'We are so proud of him!"

Kasten nailed 72 out of 75 on the 16-yard line.

"Only seven kids out of the 1,600 shot a perfect 75," Dee said, "so that put him in the top tier of shooters."

For his handicap, Kasten had to shoot at the 24-yard line, and he hit 60 out of 75 but fell short of a trophy.

"If he would've shot six more rocks in total (16s or handicap) he would have placed out of the 1,600 kids," Dee said. "That's how crazy this competition is and how close he was to placing."

His teammate, Michael Day, was the state champion for the 16yard line competition and second at state for high overall.

#### SID#5 Covenants - Architectural Control

The Buccaneer Bay Architectural Control process of reviewing requests for changes on your property is now being managed by Teresa Dilts and Kayla Graff. They will be working with Mike Jensen, Cass County Zoning Administrator.

There are 8 sets of Covenants for Buccaneer Bay. It seems like every time a new section of Buccaneer Bay opened up another set of covenants was made. I try to make sure that every resident in Buccaneer Bay gets a copy of the covenants that is for their section of the neighborhood. Some realtors will provide a copy of the covenants to the buyer, but I don't think all of them do. Most of the covenants have some sort of termination clause.

All sets of covenants are filed at the Register of Deeds office at the Court House. Not all of the covenants have the same number of years that the covenants are in force.

HILLS COVENANTS in the second section titled: "AMENDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS", which covers the following: These covenants shall run with the land and be binding upon the current and future Owners of all Lots in Blocks One (1) through Six (6), inclusive; all Lots in Blocks Fifteen (15) through Twenty (20), inclusive; Lots one (1) through Five (5) in Block Seven (7), and; Lot Ten (10) in Block Fourteen (14), all in Buccaneer Bay, a subdivision as surveyed, platted and recorded in Cass County, Nebraska, until the year 2029, together with any Lots created by a replat of these Lots, and shall be continued for successive periods of twenty-five (25) years unless sooner modified or terminated in writing by seventy-five percent (75%) or more of the then record owners of the Properties, with one vote per Lot.

BAY LAKE COVENANTS in the second section titled: "AMENDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS", which covers the following Blocks: Block 21, 22, 23, 24, and 26 until the year 2000, at which time the covenants shall be extended for *successive terms* of 25 years, which should make them good until 2025.

**Block 31 in Buccaneer Bay** incudes Windward Dr. and all side streets in this section, approved in September 2008 for term of 25 years, which would then expire in 2033.

Blk 28 Lots 8A/B, Lots 9A/B, and Lot 10 on Lakeside Dr. These first 2 townhomes and one house are under the original covenants for Lakeside Dr. approved May 18, 2005 for a term of 25 years, which should terminate in 2030.

Blk 28, Lots 1A – 24B, minus Lots 8A/B, 9A/B and Lot 10 on Lakeside Dr. as described in the Covenants from Lone Tree Holdings. Approved May 18, 2017 for a term of 30 years, which would terminate in 2047.

**Bucc Bay 1st Edition – Lots 1R – 39R** – Davy Jones Dr. and Davy Jones Cir. Filed February 14, 1996 for a term of 25 years. These Covenants have expired.

Blk 29 Lots 1-26 Fairway Cir., Blk 30 Lots 1-6 – Fairway Dr. – Covenants and restrictions shall run with and bind the land and for a term of twenty-five years. Filed May 18th, 2005, which would expire in 2030.

Blk 27 Lots 1A – 20B, and Lots 21 – 62 – Sailboat Lake – The Covenants and restrictions shall run with and bind the land for a term of 25 years. Filed December 23, 1996, the Covenants have been renewed.

Residents under the covenants that will be expiring can be renewed by having residents who want to have the covenants continue review and update them. Each set of covenants has a specification of how many signatures are required to approve the revised covenants. It has been done, but it takes a lot of work. Once the covenants are out of date, that section of residents will no longer have to follow any restrictions for their section.

Note: The process below may be modified as the Newsletter and Welcome Packages are being updated.

Each time a new resident moves in they receive a Welcome Package that has a copy of the covenants for their location. The information on new residents come in an email from Peoples Service. Jill Bobenhouse-Teaser will take on putting the Welcome Packages together and provide the packages to the appropriate Block Captain so the new resident can fill out a Data Sheet to be sent to one of the members taking over for Janet. The changes will require the new information to be added to the Buccaneer Bay Phone Directory, if the new resident approves, and update the Block Captains list as residents move in and out.


