

Getting to know Buc Bay residents

Golf is the tie that binds couple

ayne and Pam Petersen have perhaps the best view of the golf course from the deck of their home on the Boulevard overlooking the fifth green. The course has a special place in their hearts, because it's where they met for the first time on a true blind date. And it marked

the start of a journey that led to their marriage 13 years ago.

So how did a couple who led separate lives so many years ago meet, wed and end up in Buccaneer Bay?

Let's start with Pam, who was born in Omaha but grew up in Council Bluffs. She graduated Thomas Jefferson High School and, just a month later, began a 40-year career with Union Pacific. She retired barely a year into her marriage to Wayne.

Pam clearly remembers her early Union Pacific years.

"When I was hired in

1972, it was a man's world," she said. "I was this young female, and there were two other women working in the yard office.

"I had more uncles and grandpas looking out for me."

She admits that she might not have gotten the U.P. job without some help.

"My grandpa drank beer with the terminal superintendent," Pam said. "He told him, 'My granddaughter is graduating from high school. Is there anything for her?' He said, 'Can she type?' My grandpa said I could, and he said, 'Send her over.'

Wayne grew up in Schuyler, about 70 miles west of Omaha.

"I was born in Fremont," Wayne said. "My dad bought a farm near Schuyler in 1959. Schuyler is what I consider my home."

Growing up on a farm wasn't easy for Wayne. Among the animals they nurtured was a flock of 10,000 chickens.

"We had row crops, we raised hogs, we raised cattle," he said. "When I was in high school, we got out of the hogs and the cattle and built a chicken laying house. Dad fed them, but we had

> to gather the eggs. I remember gathering 8,000 eggs in one day."

> Before attending Schuyler High, Wayne attended a one-room school until eighth grade.

One of his classmates from Schuvler High's Class of 1968 was Chuck Jura, who along with basketball team.

Gene Harmon (Class of 1970), played on the Class B state championship team was nicknamed "the Jolly Green Giants" for their heighth and green jersey color.

(Jura went on to play for Nebraska and was drafted by the Chicago Bulls in the

third round, and Harmon starred at Creighton from 1971-74. Harmon died in 2015 at age 63.)

"There are 12 of us (from Schuyler High) who get together the fourth Saturday of June for a golf outing," Wayne said. "Chuck is one of them. This past June was our 40th year. It's called GANT, Golf Across Nebraska Tournament."

Wayne played Legion Baseball, and many of his former teammates are in that group of 12 golfers. Wayne wasn't able to make this year's reunion golf outing - but he had a good reason. He was officiating the wedding of the daughter of Pam's cousin. (Wayne became an online ordained minister.)

"He was nervous," Pam said, "but it went well."

Backing up a bit, Wayne attended Southeast Community College in Milford (just west of Lincoln) in 1969 and graduated in July 1970 with an associate degree in architectural drafting.

He worked as a salesman for three Minnesota housing companies from 1976 until he retired in 2021 — working remotely at first from Schuyler.

After his 2004 divorce, Wayne moved to Lincoln.

During her first marriage, Pam lived in Council Bluffs within walking distance of her parents, grandparents and other family members. Pam and her husband got transferred to Portland, Ore., in 1979. The next year, Mount St. Helens erupted.

After her first marriage ended 15 years later, Pam eventually began golfing in the Bay Hills Wednesday women's league. One of Pam's golf friends asked if she'd be interested in meeting a "nice" guy.

Recalls Pam: "I asked her, 'Are there any left?' I'd been divorced since 1990, and this was 2006."

The weeks passed before Pam and Wayne would be introduced for the first time - at the Bay Hills Golf Club - on Aug. 3, 2006.

"We met as a blind date playing golf," Wayne recalls. "It took place in the parking lot. She had me at 'hello.'"

Said Pam: "We rode together in the same cart. We played 18 holes, and No. 7 became our special hole. We were playing a scramble, and he hit his ball on No. 7 over the green. It was my turn to hit, and I chipped it in for a birdie."

The couple went out to eat, but Wayne neglected to get Pam's phone number at the end of the date.

"I had been married for 27 years," Wayne explained. "How do you go about dating somebody after you were married so

long?"

Wayne eventually got her number, and he asked her to a Husker football game. Their second date went well.

Three days later, during a routine physical exam, Wayne's doctor found a problem with his heart.

"I had four stints put in my heart," Wayne said. "She had nothing to do with it. It came out of the blue."

They continued dating for almost five years, which left Wayne wondering where the relationship was headed. That all changed on a trip they took to Arizona in April 2011.

"He decided he was going to propose to me," Pam said. "I had no clue."

Wayne presented Pam with a dozen roses, which came with a card that read: "Will you marry me?"

Wayne had received the OK from all of their children, but he

admitted being a bit worried about whether Pam would accept the proposal.

Said Pam: "You could tell by the look on my face that I was shocked."

The wedding took place Sept. 16, 2011, and the reception was held, most appropriately, at the Bay Hills clubhouse. A large tent was placed on the east side of the clubhouse, and all their children and grandchildren were there.

At the time, the couple lived in Council Bluffs but just a year later contemplated a move. The question was: to where?

One day, Wayne was playing golf with Mike Buchman, who

tipped Wayne off that his next-door neighbor was about to place his home on the market. They arrived in May 2013.

"I hadn't considered moving there," Pam said. "I wanted it to be special, a neat place to go. I was afraid it wouldn't be special. When I saw this place, I said, 'Yes, yes, yes.' We struck the deal at their kitchen table with a hug, not a handshake."

Today, the Petersen family has grown to 10 grandchildren and, at the end of last month, they became great-grandparents. They have plenty of room for family gatherings.

Over the past 11 years, Pam and Wayne have made many lasting friendships and couldn't be happier in Buccaneer Bay.

"I think we probably have one of the best views (looking east)," Pam said. "We love it here."

Dear S.I.D. Property Owner:

The following are instructions on how to vote for your Sanitary and Improvement District (S.I.D.) Board of Trustees. This election is an election by mail. The official date of the election is Tuesday, September 10, 2024. The deadline for receipt of voted ballots in the Cass County Election Commission office is Tuesday, September 10, 2024 at 5:00 p.m.

Please note: A drop box is available 24/7 at 346 Main St. Plattsmouth NE 68048. West side of the courthouse, just south of the doors, if you do not return by mail.

If you own more than one parcel in the same S.I.D., Ballot Two will have a number printed at the bottom of the ballot indicating the number of lots or acres owned. This number indicates the number of votes cast for each candidate you choose (for example, if the number is 12, each person you vote for will receive 12 votes).

PLEASE FOLLOW THESE INSTRUCTIONS PRECISELY, FAILURE TO FOLLOW THESE INSTRUCTIONS COULD RESULT IN YOUR BALLOT NOT BEING COUNTED.

- 1. Fill in the OVAL to select your candidate.
- 2. Write-in candidates are accepted. Write the name of the candidate on the line provided, and place a fill in the Oval. A write-in candidate must be a property owner in the district or must be a designated representative of a partnership, Limited Liability Corporation (LLC), corporation, estate, or trust which owns real estate in the district. The name of a designated representative shall be accompanied by the name of the entity that the candidate represents, and the Election Commission must receive written documentation designating the candidate as a representative within 10 days following the election.
- 3 After marking your ballot, seal the ballot inside the return envelope. Persons or corporations owning property in more than one S.I.D. must place the ballot for each individual S.I.D. in the return envelope with the corresponding S.I.D. number.
- Return your ballot, enclosed envelope, by mail or in person to the Cass County Election Commission, 145 N 4th St, Plattsmouth, NE 68048, by 5:00 p.m. on Tuesday, September 10, 2024.

Buc Bay residents make TV news

Two of our Buccaneer Bay residents were featured on back-toback KMTV newscasts last month. Tony "Wojo" Wojtalewicz was recognized as a member of the Council Bluffs Fire Department, which was honored in Washington, D.C., last month for its commitment to veterans. Christina Elder capped a busy

summer on the track at the USTAF World Championships in Sweden.

Tony, who lives on Sailboat Lake, nominated his fire department for the "Secretary of Defense Employer Support Freedom Award" and, out of more than 1,700 nominees, CBFD was one of 15 selected.

"This isn't about me," Tony told Channel 3. "I was just the guy to facilitate the process really."

A firefighter/paramedic and also a first sergeant in the U.S. Army Reserves, Tony said it starts with the chief and his willingness to support and hire guardsmen and reservists knowing their military

duties may take them away from the fire department.

"I can teach pretty much anyone to fight fire," said Fire Chief Justin James. "It's hard to teach service, sacrifice and then life experience."

Tony, who serves as an assistant fire chief, was at the Pentagon Aug. 22 to receive the award on behalf of the department.

Christina's August trip took her to Gothenburg, Sweden, for the USATF World Masters Athletics. She competed in the 35 age group's 400 meters, 800, 4x100 relay and 4x400 relay.

She placed eighth in both the 400 (59.61 seconds) and 800 (2:19:54) finals. After Christina's Team USA took bronze in the 4x100 (49.36), she ran the second leg on Team USA's gold-medal 4x400 relay team that finished in 3:51.54.

"So grateful for Team USA, the opportunity to be selected on a relay and the experience as a whole," Christina wrote on her Facebook page. "After I put my mark down I looked around the stadium and literally thought to myself, 'This is so cool.'"

She called it an "experience like no other. Alongside my sisters to the USA Team managers and my teammates, thank you for trusting me to do my job — even though I'm a long sprinter/mid-distance."

Pet of the month: Razor

Hard as it is to believe, fall college and high school sports have kicked off, meaning summer is winding down. That doesn't mean you need to dig out the sweaters, because our toasty days likely will stick around.

Football season continues to be big for many of our Buc Bay residents who root for the Big Red, despite the struggles of that once-proud program in Lincoln that hasn't had a winning season since 2016 (seems longer than that). As is the case each time this year, Husker fans predict great success for their team, only to be stunned by close and not-so-close losses in recent years.

It reminds me of the "Peanuts" cartoon where Lucy promises

I'm not near the diehard fan I was growing up. When we moved to Nebraska (Papillion) in 1963, I didn't know there was a football team in Lincoln. But after watching my first game in person, I was hooked. Of course, it didn't hurt that my folks were as well.

I'll always remember my mom getting stressed out over close games. She wanted every win to be a blowout. They started attending NU bowl games in 1969, when the Huskers played in the Sun Bowl in El Paso, Texas. I remember that not just for the fact they won (45-6 over Georgia) or that it was the first of 35 consecutive NU bowl appearances. Here's what happened:

I was into my senior year at Papillion High School, and my dad asked if I'd be willing to pick them up at the airport. Their flight wasn't to land until late at night, and I fell asleep by the phone while waiting for their arrival.

When the call finally came, my dad told me a snowstorm had forced the flight to be diverted to Kansas City, and they were going to take a train to downtown Omaha. I don't recall how they eventually got home, but I remember not having to pick them up.

Little did I know at the time that 19 years later I would be working for the Omaha World-Herald and get the chance to cover a Husker football game. (The story of the 1995 NU-Michigan State game is in my autobiography, which you can order from me.)

I'll always remember during our paper's massive reporting of Husker football (just as it continues today) the many phone calls about it. For each fan who stated, "You don't cover the Huskers well enough," we got 10 calls complaining we devoted far too much space on them. "I don't give a hoot about Nebraska football," many would yell into their phones. "I'm from (wherever)."

Fast-forward to our seven-plus years here, and my passion for Nebraska football has subsided quite a bit — especially with the arrival of NIL (Name, Image, Likeness) and the transfer portal. Now the news is that schools must pay their athletes?

Still, I must confess that I look forward to Husker game days, but over the past few years it's not been a matter if NU will lose but by how much.

With the season-opening win over Texas-El Paso, maybe this will be the year things turn around. Husker fans can only hope.

We learned last month that more work on Hwy 75 began (again). Since moving here in 2017, has there been a complete year where there were no cones on that highway? Yes, it's something that has to be done, but why can't they get things right the *first* time?

It appears that it's something we'll just have to get used to, but I'd like to see these "fixes" get done in my lifetime.

Yard waste participation is lacking

On the Buc Bay Facebook site last month, SID Board member Dave Martin wrote:

"We regret to inform you that Gretna Sanitation is currently unable to recycle yard waste from our district. Despite their efforts, the high volume of regular trash mixed with yard waste has necessitated sending the material to the landfill.

"Currently, 198 residents have yard waste bins, but only a small number are regularly using them. For Gretna Sanitation to continue yard waste recycling, the service must be economically viable.

"To improve the situation, Gretna will be monitoring yard waste bin usage over the next few months. If usage increases and the yard waste is consistently clean, they will resume recycling. However, if the contamination issue persists, we may need to consider discontinuing the service or possibly adjusting the pickup frequency to every other week.

"We appreciate your cooperation in keeping yard waste separate from regular trash and will keep you updated on any further changes."

Utility rate changed last month

The SID also informed residents of changes to the SID 5 Utilities Fee Ordinance, which went into affect on all utility bills in July 2024. The changes were to be reflected on August bills.

Effective July 1, 2024:

Wastewater treatment plant debt service fee: This fee will increase from \$16 to \$21 per month. This adjustment is necessary to cover the cost of the state bond used to expand the capacity of our wastewater treatment plant, improve system monitoring and replace the Sterling Court lift station.

By law, the cost of the state bond must be shared equally by all customers of the system. This project was started prepandemic and original cost estimates of the project would not have required an increased the debt service fee. Unfortunately, the cost of the project sky rocketed post pandemic forcing an increase in the fee.

Trash fee: A new fee of \$22.95 per month will be assessed for each active water account with a habitable residence.

Dave added: "Please note that there will be no changes to the current water or sewer usage rates. The maintenance costs on the system have started leveling off and we are not planning on any usage rate increases anytime soon.

"Please contact the Board with any questions."

Renovation of Buc Bay Water tower

The Buccaneer Bay water tower's interior renovation and exterior painting began late last month. During the renovation,

residents are asked to limit water usage as much as possible because the tower will be drained for several weeks. Residents should read the project's details as it affects water usage during the early hours of the day. Click on this link:

Speaking of water, the SID still recommends adherence to the Buc Bay outdoor water policy. It states:

- Even numbered addresses may water lawns and landscaping only on Tuesday, Thursday, and Saturday.
- Odd numbered addresses may water lawns and landscaping only on Wednesday, Friday, and Sunday.
- Watering lawns or landscaping is not allowed on Monday.
- If the property owner waters the lawn and landscaping only with a rain water reclamation system or the owner's private sand point well, and does not use the District's water system, the owner is exempt from these rules and regulations.


Bay Hills sinks Lake Ridge again



SID#5 Covenants - Architectural Control

The Buccaneer Bay Architectural Control process of reviewing requests for changes on your property is now being managed by Teresa Dilts and Kayla Graff. They will be working with Mike Jensen, Cass County Zoning Administrator.

There are 8 sets of Covenants for Buccaneer Bay. It seems like every time a new section of Buccaneer Bay opened up another set of covenants was made. I try to make sure that every resident in Buccaneer Bay gets a copy of the covenants that is for their section of the neighborhood. Some realtors will provide a copy of the covenants to the buyer, but I don't think all of them do. Most of the covenants have some sort of termination clause.

All sets of covenants are filed at the Register of Deeds office at the Court House. Not all of the covenants have the same number of years that the covenants are in force.

HILLS COVENANTS in the second section titled: "AMENDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS", which covers the following: These covenants shall run with the land and be binding upon the current and future Owners of all Lots in Blocks One (1) through Six (6), inclusive; all Lots in Blocks Fifteen (15) through Twenty (20), inclusive; Lots one (1) through Five (5) in Block Seven (7), and; Lot Ten (10) in Block Fourteen (14), all in Buccaneer Bay, a subdivision as surveyed, platted and recorded in Cass County, Nebraska, until the year 2029, together with any Lots created by a replat of these Lots, and shall be continued for successive periods of twenty-five (25) years unless sooner modified or terminated in writing by seventy-five percent (75%) or more of the then record owners of the Properties, with one vote per Lot.

BAY LAKE COVENANTS in the second section titled: "AMENDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS", which covers the following Blocks: Block 21, 22, 23, 24, and 26 until the year 2000, at which time the covenants shall be extended for *successive terms* of 25 years, which should make them good until 2025.

Block 31 in Buccaneer Bay incudes Windward Dr. and all side streets in this section, approved in September 2008 for term of 25 years, which would then expire in 2033.

Blk 28 Lots 8A/B, Lots 9A/B, and Lot 10 on Lakeside Dr. These first 2 townhomes and one house are under the original covenants for Lakeside Dr. approved May 18, 2005 for a term of 25 years, which should terminate in 2030.

Blk 28, Lots 1A – 24B, minus Lots 8A/B, 9A/B and Lot 10 on Lakeside Dr. as described in the Covenants from Lone Tree Holdings. Approved May 18, 2017 for a term of 30 years, which would terminate in 2047.

Bucc Bay 1st Edition – Lots 1R – 39R – Davy Jones Dr. and Davy Jones Cir. Filed February 14, 1996 for a term of 25 years. These Covenants have expired.

Blk 29 Lots 1-26 Fairway Cir., Blk 30 Lots 1-6 – Fairway Dr. – Covenants and restrictions shall run with and bind the land and for a term of twenty-five years. Filed May 18th, 2005, which would expire in 2030.

Blk 27 Lots 1A – 20B, and Lots 21 – 62 – Sailboat Lake – The Covenants and restrictions shall run with and bind the land for a term of 25 years. Filed December 23, 1996, the Covenants have been renewed.

Residents under the covenants that will be expiring can be renewed by having residents who want to have the covenants continue review and update them. Each set of covenants has a specification of how many signatures are required to approve the revised covenants. It has been done, but it takes a lot of work. Once the covenants are out of date, that section of residents will no longer have to follow any restrictions for their section.

Note: The process below may be modified as the Newsletter and Welcome Packages are being updated.

Each time a new resident moves in they receive a Welcome Package that has a copy of the covenants for their location. The information on new residents come in an email from Peoples Service. Jill Bobenhouse-Teaser will take on putting the Welcome Packages together and provide the packages to the appropriate Block Captain so the new resident can fill out a Data Sheet to be sent to one of the members taking over for Janet. The changes will require the new information to be added to the Buccaneer Bay Phone Directory, if the new resident approves, and update the Block Captains list as residents move in and out.
