

Getting to know Buc Bay residents

He helps others weather storms

B uc Bay resident Adam Stoskopf knows the insurance industry quite well. After all, he's been in the business ever since graduating from Kansas State University. As an agent for Farmers, he's also had the misfortune of needing to file his own claims, including damage from the 2019 flooding of Bay Lake (he and wife Becky live on the lake's south end on Cape Horn Circle) and, just a couple months ago, a deer collision.

So how did a native of a small Kansas town end up in Nebraska? Through his job, naturally.

Adam graduated from high school in El Dorado, Kan., located about 30 miles northeast of Wichita. He enjoyed playing baseball and golf while growing up there. While in high school, he had an inkling of what vocation he might pursue and what path he would take to get there.

"My father was a small business owner, nothing to do with insurance," Adam

said. "He owned a Hallmark store in town, so business in general interested me. I settled on Farmers, because my uncle had a really long and successful career with them."

He got his start by enrolling at Kansas State, majoring in marketing. Choosing KSU was easy for Adam, even though he had family members who attended K-State's top rival, Kansas University.

"One of my high school coaches played football at Kansas State," he said. "I had a job on the coach's video staff for the football team. I was at every practice, every game for my five years there. It was a job I couldn't pass up."

After graduation in 2006, Adam took his first job with Farmers out of Olathe, Kan., starting on the corporate side in the claims division. He eventually became familiar with the catastrophic logistics side of the industry and marketing of insurance ser-

vices.

In 2012, he jumped on the opportunity to uproot from the Kansas City area to Omaha.

"I had never been to Omaha before in my life," Adam said. "I had been to Lincoln when Kansas State played Nebraska. We actually were 3-2 in my five years against Nebraska."

Adam's first Omaha office was near 137th and Dodge Streets, and he lived near 168th and Blondo. A couple years later, he attended an insurance conference at Prior Lake, Minn., southwest of the Twin Cities. That turned into a life-changing event for Adam.

Said Adam: "One of the agents said, 'I should set you up on a

blind date.' I was in my early 30s and single. One thing led to another, and I actually ended up going on the blind date. It was

a little nerve-racking, but you have to have faith in the people who set you up."

Becky Rogers (a native of Chappell, Neb.) and Adam hit it off from the start, and just two years later (2016), they were wed in a ceremony that took place in Estes Park, Colo.

Adam immediately became a family man as Becky had four children from a previous marriage. The couple added a fifth with the arrival of a daughter. Becky's older sons are out of high school, and the twin daughters are juniors at Plattsmouth High.

The Stoskopfs moved into their Buc Bay home in 2015 and immediately embraced lake life while getting to know others on their circle.

"The lake was a big, big draw," Adam said "The kids were constantly out there fishing, swimming and paddle boarding." Then came the March flood of 2019, and everything changed.

"We had evacuated the night before to a friend's house here in the area," Adam said. "We had moved some stuff upstairs but not a lot."

> The family had no idea what they were about to discover when they were allowed to return home. Adam envisioned ankle-deep water in their basement, but it was much worse. Water was chest-high deep, and the damage was extensive.

> "We had to tear everything out," he said. "It was quite a process. We were thankful to have a lot of wonderful people who volunteered their time to help. That was a huge undertaking, and it was amazing. It was people from the Buccaneer Bay area and others from Plattsmouth in general."

> A couple months later came another monster rain, and Adam and another flock of volunteers prepared by placing sandbags around their home.

As an insurance agent, filing a

claim is relatively easy, as you might suspect. But it's the same process.

"You file a claim," Adam said, "and then the adjuster comes by, assesses the damage and takes pictures."

Having lived in the Midwest his entire life, Adam has helped his policy-holders deal with floods, tornadoes, windstorms and, very often, hail damage.

"Tornadoes are absolutely devastating, especially for those affected," he said. "The scope is kind of limited, because the tornado has its path. Windstorms are our version of a hurricane. When thousands of customers need a new roof, it all adds up."

Due to the various disasters that hit this part of the country, insurance premiums have been on the rise. Yes, Adam admits, Nebraska ranks near the top in premium costs. Over the years, all the claims take a toll on insurance companies' profit margins.

Adam pointed to a 2023 study that revealed insurance companies were paying out \$1.12 for every dollar they collected.

"That's everything, including the cost of doing business and paying claims," he said. "It's not good for the bottom line."

Despite the occasional disaster, Adam believes life in the Midwest is pretty good, especially here in Buccaneer Bay.

"We really like the small-town feel, the heart of everyone," he said. "I think of the people who were here to help us recover from the flood. That really epitomizes why we're here."

Work begins on water pipeline

Many of our Buc Bay residents may have noticed the preliminary work being done near Buccaneer Boulevard as part of the planned water pipeline that will run through parts of our development and, eventually, end in Plattsmouth. Kurt Meisinger, chair of SID #5, was glad to provide information about the Metropolitan Utilities District pipeline that will run under the Platte River.

Discussions about the water service connection began after the historic 2019 flood that wiped out the city's wastewater and water treatment plants. Plattsmouth city officials began working with the Federal Emergency Management Agency on flood recovery projects and investigating a way to secure a new and better source of drinking water.

"This is a City of Plattsmouth project," Kurt said. "It is not a Sanitary Improvement District project. The SID is just a property owner that the city is utilizing like other property owners."

The pipeline will start on the north side of the Platte River, where MUD's water treatment plant is located, and go under the Platte and into private land until reaching SID property. (Trees were removed from the land at the end of Treasure Island Road.) From there, the pipeline will run parallel to the Burlington Northern railroad tracks. It will run under Sailboat Lake property, going west to golf course property.

From the golf course, the pipeline runs parallel to Buccaneer Boulevard toward the main entrance. It next crosses Buc Boulevard toward the mailbox parking lot before jutting to Bay Road, where it will run parallel on the south side.

FEMA reportedly is providing 90 percent of the estimated \$23.5 million cost of the water main for Plattsmouth. Because of the FEMA funding, Buccaneer Bay is not allowed to tap into it.

"If that water line is used to feed us, it is no longer feeding the City of Plattsmouth," Kurt said, "and they would lose their FE-MA money."

Kurt said that residents living close to the pipeline route shouldn't worry about damage near their property.

"They will be doing (directional) boring, rather than trenching," he said.

The project is expected to be completed by June 2027.

Staying on the topic of water, Kurt was asked if Buc Bay residents should be concerned about the lack of precipitation we endured from October to the first significant snowfall on Feb. 12 causing issues with our water table.

"Our water table is still reading just fine," he said. "We're deep enough that surface water does not impact us. When we've had concerns of our water usage, it's because during the summer when everyone is watering.

"The usage now (winter) is probably 20 percent of what it is in August because of the people watering yards. If it was this dry in June, July and August, then we might be more concerned because of the draw on the usage."

"According to Papio-Missouri NRD General Manager John Winkler, this unplanned repair work is due a sewer manhole top that failed on the Omaha Wastewater Treatment Plant's 96 -inch interceptor sewer system.



A tough lie in Arizona





✓ Put a check in front of each statement that is true for your home.

Smoke Alarms

- Smoke alarms are on every level of the home.
- Smoke alarms are inside and outside sleeping areas.
- Smoke alarms are tested each month.
- Smoke alarm batteries are changed as needed.
- Smoke alarms are less than 10 years old.



Test your alarm regularly.

Your smoke alarm is working if it makes a noise when you press the "test" button.

Cooking Safety

- The cooking area has no items that can burn.
- People stay in the kitchen when they are frying, grilling, boiling, or broiling food.
- Pot handles are always turned toward the back of the stove.

Escape Plan

- There is a fire escape plan that shows 2 ways out of every room.
- Everyone knows where the safe meeting place is outside the home.
- Everyone living in the house practices the escape plan 2 times a year.

Carbon Monoxide Alarms

- Carbon monoxide alarms are located on each level of the home.
- Carbon monoxide alarms are less than 7 years old.

Electrical and Appliance Safety

- All electrical cords are in good condition and not broken or cut.
- People clean the dryer of lint after every use.
- All plug outlets are safe and do not feel warm when you touch them. (If they are warm, call the landlord or an electrician.)

Candle Safety

- Candles are in sturdy fire-proof containers that won't be tipped over.
- Adults blow out all candles when leaving the room or going to bed.
- Candles are kept out of reach from children and pets.



Children are sometimes curious about fire.

If you have children in your home, lock up any items that can start a fire (matches. lighters, cigarettes, etc.) and make sure children cannot reach candles.







SID#5 Covenants - Architectural Control

The Buccaneer Bay Architectural Control process of reviewing requests for changes on your property is now being managed by Teresa Dilts and Kayla Graff. They will be working with Mike Jensen, Cass County Zoning Administrator.

There are 8 sets of Covenants for Buccaneer Bay. It seems like every time a new section of Buccaneer Bay opened up another set of covenants was made. I try to make sure that every resident in Buccaneer Bay gets a copy of the covenants that is for their section of the neighborhood. Some realtors will provide a copy of the covenants to the buyer, but I don't think all of them do. Most of the covenants have some sort of termination clause.

All sets of covenants are filed at the Register of Deeds office at the Court House. Not all of the covenants have the same number of years that the covenants are in force.

HILLS COVENANTS in the second section titled: **"AMENDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS"**, which covers the following: These covenants shall run with the land and be binding upon the current and future Owners of all Lots in Blocks One (1) through Six (6), inclusive; all Lots in Blocks Fifteen (15) through Twenty (20), inclusive; Lots one (1) through Five (5) in Block Seven (7), and; Lot Ten (10) in Block Fourteen (14), all in Buccaneer Bay, a subdivision as surveyed, platted and recorded in Cass County, Nebraska, until the year 2029, together with any Lots created by a replat of these Lots, and shall be continued for successive periods of twenty-five (25) years unless sooner modified or terminated in writing by seventy-five percent (75%) or more of the then record owners of the Properties, with one vote per Lot.

BAY LAKE COVENANTS in the second section titled: **"AMENDED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS"**, which covers the following Blocks: Block 21, 22, 23, 24, and 26 until the year 2000, at which time the covenants shall be extended for *successive terms* of 25 years, which should make them good until 2025.

Block 31 in Buccaneer Bay incudes Windward Dr. and all side streets in this section, approved in September 2008 for term of 25 years, which would then expire in 2033.

Blk 28 Lots 8A/B, Lots 9A/B, and Lot 10 on Lakeside Dr. These first 2 townhomes and one house are under the original covenants for Lakeside Dr. approved May 18, 2005 for a term of 25 years, which should terminate in 2030.

Blk 28, Lots 1A – 24B, minus Lots 8A/B, 9A/B and Lot 10 on Lakeside Dr. as described in the Covenants from Lone Tree Holdings. Approved May 18, 2017 for a term of 30 years, which would terminate in 2047.

Bucc Bay 1st Edition – Lots 1R – 39R – Davy Jones Dr. and Davy Jones Cir. Filed February 14, 1996 for a term of 25 years. These Covenants have expired.

Blk 29 Lots 1-26 Fairway Cir., Blk 30 Lots 1-6 – Fairway Dr. – Covenants and restrictions shall run with and bind the land and for a term of twenty-five years. Filed May 18th, 2005, which would expire in 2030.

Blk 27 Lots 1A – 20B, and Lots 21 – 62 – Sailboat Lake – The Covenants and restrictions shall run with and bind the land for a term of 25 years. Filed December 23, 1996, the Covenants have been renewed.

Residents under the covenants that will be expiring can be renewed by having residents who want to have the covenants continue review and update them. Each set of covenants has a specification of how many signatures are required to approve the revised covenants. It has been done, but it takes a lot of work. Once the covenants are out of date, that section of residents will no longer have to follow any restrictions for their section.

Note: The process below may be modified as the Newsletter and Welcome Packages are being updated.

Each time a new resident moves in they receive a Welcome Package that has a copy of the covenants for their location. The information on new residents come in an email from Peoples Service. Jill Bobenhouse-Teaser will take on putting the Welcome Packages together and provide the packages to the appropriate Block Captain so the new resident can fill out a Data Sheet to be sent to one of the members taking over for Janet. The changes will require the new information to be added to the Buccaneer Bay Phone Directory, if the new resident approves, and update the Block Captains list as residents move in and out.
